A FEW RULES FOR YOUR SAFETY AND THE ENJOYMENT OF THE WATER

1. **Swim within your limits.** Do not go further than you are comfortable swimming.
2. **There are no lifeguards on duty.** For your own safety, please swim only when supervised by an adult from your group.
3. **Stay within the buoys.** We cannot control boat traffic outside our buoys and ropes.
4. **Stay out from under boats, docks, water trampolines, and other aquatic fixtures.**
5. **No diving is allowed.** Please, enter the water feet first as our swimming area is not deep enough to dive.
6. **Please do not throw rocks.**
7. **Water trampoline/raft-** We recommend no more than three on at a time. Please allow others to have a turn. Jump off feet first away from other swimmers in the water.
8. **Boats-** Please stay within the boating area. Lifejackets must be worn at all times. Adult supervision required for all participants under the age of 18.

SUGGESTIONS:

- A. Have at least one adult on shore watching at all times.
- B. If there are swimmers *and* boaters present, have one adult supervising each group.
- C. To avoid temptation, keep all children away from the waterfront when no adults are present.

LIABILITY RELEASE

Water Front Use at Green Lake Lutheran Ministries

The members of the group will swim at their own risk.

The group agrees that, in the event that a member of the group incurs any psychological, physical, or emotion injury or is killed while using GLLM water front property or materials; all members voluntarily release GLLM, its directors, officers, employees, agents, or representatives from any and all liability for the incident.

The group understands and agrees that this release applies to not only themselves, but also their estates, heirs, and assigns. In the event some other person or entity seeks compensation for these related liabilities, they and their estates will indemnify and hold harmless the whole GLLM organization.
